REGISTERING FOR EXAMS

When an applicant registers for an exam, they are expected to provide the date of the exam they will be taking. At that point, they will receive a link to schedule through Proctor U, if they are utilizing the remote proctor. If they choose a different date through Proctor, U, they are still required to notify the office that the date has changed. If they do not do this, the exam will be scheduled for the original date and there will be no exam for them in the testing portal on the date scheduled through Proctor U. They will be unable to schedule with Proctor U prior to registering through the AAHAM website.
